

## **Account, pay-outs and bonuses**

The Client shall be entitled to gamble when the funds are available on his Account. Gambling limits can be determined by each game and for each country separately and should be followed by Client.

In case there are no monetary funds on the Account the Company is entitled to refuse to the Client to participate in gambling. Refusal of the Company can be made both by reference to the reasons for the refusal and by unmotivated technical restrictions on the capability of the Client to perform gambling operations.

The Client's wish to withdraw the Account balance can be limited by the transactions maximums as shown on the Website. Note that fees may apply as outlined on the Website. The Company may limit the Client's right to withdraw the winning that was received by the Client as a result of unlawful or unfair acts or as a result of non-compliance with the terms of Terms of Service of the Company.

The following methods of crediting the funds to the Account are available:

- Bank transfer
- E-wallet
- Crypto currency

The procedure for crediting the funds by each method specified herein, procedure for and conditions of making payments are determined on the Website of the Company.

The Client is considered to have fulfilled the obligation of crediting the money and can be permitted to gamble under his instructions after the receipt of the relevant funds to the account of the Company or acceptance of them by the Company in a different form.

Before the occurrence of the said circumstances the Company is entitled to establish technical barriers to perform the Gambling Operations by the Client.

The receipt of the funds by the Company for the purposes of this document should be deemed to be the time of appearance of information about the relevant balance on the Client's account.

The Company has the right to change or add the methods of replenishment of the Account. The corresponding changes to this document shall become effective upon its' renewal in the Website.

Performance by the Client of any operation or transfer of the funds to the Company is considered to be the acceptance by the Client of these rules. Acceptance of the funds transferred by the Client to deposit on its Account, is performed by the Company within the following terms:

- immediately after the payment transaction if the Client uses the methods of transfer of the monetary funds referred to herein;
- within 24 hours from the moment of payment, but not earlier than on the day of confirmation by Payment Service Provider (hereinafter – PSP) of the Company of compliance of the payment made in accordance with the Terms of service of the Company, including establishment of the legitimacy of using by the Client of the relevant bank card, if the client uses the method specified herein.

The conditions of the settlements are specified in the relevant sections of the Terms of service and shall be binding on the Client.

The Company is entitled to amend to or supplement unilaterally the conditions of depositing the monetary funds on the Account of the Client. The new conditions come into force on the day of their publication on the Website.

The conditions of using by the Clients of the bank cards are determined by the agreement with the bank or other credit institution, which holds a license for this type of activity.

The settlements between the Parties shall be made in the currency of the Client account.

When depositing the monetary funds using a Bank card the legality of using the relevant card by the Client is checked by Payment Services Provider (hereinafter – PSP).

For these purposes, the PSP is entitled to request national passport or national ID card.

In case the Client refuses to provide the scanned copies of the requested documents, the Company shall be entitled to refund the monetary funds on the bank card used for making the payment, cancel any stakes made by the Client, placed with the use of the funds paid by the bank card, the legality of which is not checked by the Company, and to refuse to pay any winnings, as well as to terminate the Service.

When depositing the monetary funds using Bank Card or Bank Transfer the owner is solely responsible for failure to observe the laws of its country in relation to the gambling in the Internet.

Depositing of monetary funds to the Bonus Account is not possible.

Any funds credited to the Bonus Account as a bonus can be withdrawn by the Client only after the conditions of a bonus program (action) are met. The amount to withdraw cannot exceed the initially credited Bonus amount. All funds generated during the gaming period above the amount initially credited shall be set to zero. Other details relating to the Bonus Account shall be regulated by the applicable Terms and Conditions.
